



CHF's View on Low-Carbon Energy Opportunities

Houston is uniquely situated to help lead the world to a low-carbon future.

- Significant energy industry work is underway to prepare for a lowcarbon future.
- The size and scale of our energy sector, our deep energy expertise, resources and access to capital all argue that Houston should be the World's Low-Carbon Energy Capital.
- The region's carbon footprint is significant, and the region has seen first-hand affects from climate change.

More work must be done to unlock our potential.

- Current initiatives are not coordinated, lack a coherent vision and plan, and missing opportunities.
- The pace of change to reduce local emissions is not fast enough.
- CHF is well positioned to accelerate Houston's role in the transition.



Strategic Initiative: Health Care

Fact-finding:

- Conducted interviews with 23 key health care stakeholders representing business, universities and nonprofits.
- Held two focus groups.
- Conducted employer survey to assess employer concerns and priorities on health care.

Economic forecasting:

- Using CHF forecasting methodology established with immigration report.
- Projecting regional health care employment & GDP in 2036.

Major research report released in late March/early April 2020 at symposium. Report will include: **

- Economic profile of the region's health care sector.
- Summary of key trends (technology and models of care) reshaping the industry.
- Findings from the Center's economic forecasting.
- Recommendations on for maximizing the health care sector's economic impact.
